of them severally share and share alike And in case either of my three children Elizabeth Richard or Mary shall happen to dye before such sale or dividend made not leaving any child behind them or either of them Then my will and meaning is That his her and their share and proportion soe dyeing shall be distributed and paid to and amongst all my surviving children share and share alike But if my son William shall happen to dye before such sale and dividend and his now wife Elizabeth doe happen to survive him Then my will and meaning is That his share and proportion of money shall be paid unto Elizabeth his new wife according to an agreement made by me before their intermarriage And in case my son John shall happen to dye before his Mother or neglect in some convenient time to sell the said houses and to make such dividend and to pay to my severall children their severall proportions of money as is aforesaid in this my Will directed to be paid Then my will desire and meaning is That my son William or any other of my surviving children shall have And I doe hereby give them and either of them the same power to sell my said houses and to make such dividend and payments as my eldest son John might or could doe And as to the personall Estate which GOD hath lent me after my debts and ffunerals expenses be discharged and paid I give and bequeath the same unto Margarett my wife who I make and ordaine sole Executrix of this my last Will and Testament soe making voyd and null all Wills by me heretofore made I pronounce and declare this to be my last Will and Testament only In witness whereof I have herunto sett my hand and scale the day and yeare first above written John Piggott Signed sealed and published in the presence of William Beckford Henry Williams John Gibbons

Juditha Paske being in sound and perfect health and memory thanks be given to Almighty GOD doe make this my last Will and Testament as followeth Inprimis I comitt my soul into the hands of Almighty GOD who gave it trusting to be saved by the merits of Jesus Christ my alone Saviour and Redeemer my desire is That my body be layd into the ground with as little charge as decency doth require That which it does please GOD to blejs me withall I doe give as followeth Item I give unto the poore of the parish of Murch Madam the sum of ffive pounds And for the schooling of three poore children of the said parish the sum of six pounds Item whenas my loving Brother M^r Thomas Paske stands

Obliged to pay unto me the sum of Three hundred sixty and six pounds Thirteen shillings and four pence as it shall arise out of the profits of -
 ulls lease in the County of York I will and bequeath unto my said -
 Elizabeth Two hundred pound of the said sum And to my Godson James
 Paske the sum of fifty pounds And to my Goddaughter Judith Paske
 the sum of Ten pound and the remainder to be paid to my Executor
 hereafter named after the aforesaid sums shall be advanced Item I leave
 unto my Brother M^r Thomas Paske and his wife and to my Sister Kint
 and my Sister Dillingham Ten pounds apiece for mourning to be paid
 immediately after my decease Item I give unto Christophius Dillingham
 and Ann Blackall my Godchildren Ten pounds apiece Item I give unto
 the servants of the house where I dye Twenty shillings apiece and to my
 own servant forty shillings Lastly I make and constitute and appoint my
 loving Brother M^r George Paske sole Executor of this my last Will and
 Testament And I doe also give and devise unto my said Executor All and
 singular my houses and Tenements aswell that in Grevet Street being a
 lease from my Lord Brooke now in the occupation of one M^r Colts as
 also my meety in the three houses Stables &c in lease from my D^r Halton
 and whereof I was a joint purchaser with my Executor aforesaid Item I
 give and bequeath unto my said Executor all my moneyes goods and debts
 he performing my funerall expenses and paying all the legacies herein
 mentioned And I doe hereby revoke all former Wills and Testaments In
 witness whereof I have hereunto set my hand and seal this eighteenth day of
 January Anno Dni One Thousand six hundred ninety four and in the sixth
 yeare of the reigne of our Sovereigne Lord William King of England
 Scotland France and Ireland &c Defender of the Faith The mark of Judith
 Paske This Will was signed sealed published and declared in the presence of us
 who have subscribed our hands in the presence of the Testator Rich: Gotobed.
